Sub.- Regarding recommendations of the Expert Group for Mucormycosis for reporting of deaths due to Mucormycosis

Reference subject mentioned above, it is hereby intimated that the expert group reviewed a few deaths and opined that all the deaths couldn't be attributed to Mucorrmycosis as it could have been a contributory factor and not the independent cause of death of these cases. The recommendations of the Expert Committee for deaths due to Mucormycosis is as follows –

- a. All the districts will send the summary of the death cases reported on the day to the State HQ so that all the deaths could be reviewed by the expert committee before entering in the National portal as there is no provision in portal to update or change the information of death if entered once on portal. No distt will enter deaths on portal till verified by the expert committee.
- b. It was further decided that the following shall be responsible for sending the information of death case daily to State committee:
 - i. GMCs: Nodal Officer for Mucormycosis (Audit committees have already been constituted in GMCs)
 - ii. District: Civil Surgeon and Nodal Officer for Mucormycosis. (After collecting the information of deaths from all Govt and Private healthcare facilities in the district.)
- c. The details of Type of Case in the S3 portal should be updated timely. The nodal officers should update the column in portal as Clinically reported and Lab Confirmed. All the clinically reported cases will be taken as suspected cases and Lab confirmed cases will be confirmed cases.


