(i.e. such candidates should secure an aggregate of 52% marks or more in all the professional MBBS Exams).

  - \* In addition to type of organization mentioned at 2 (a) to (d), Sponsoring/deputation will also be accepted from Government Medical College affiliated to a University and recognized by the Medical Council/Dental Council of India.
