  - a. For MD/MS courses, the sponsored candidates who have served in the Armed Forces will be given 5% additional marks for determining their eligibility for the entrance exam. (i.e. such candidates should secure an aggregate of 50% marks or more in all the professional MBBS Exams).
  - b. For MD/MS courses, sponsored candidates in the service of the Central/State Government for 3 years or more will be given 3% additional marks for determining their eligibility for the entrance exam. (i.e. such candidates should secure an aggregate of 52% marks or more in all the professional MBBS Exams).

  - a. In addition to type of organization mentioned at 4 (a) to (d), Sponsoring/deputation will also be accepted from Government Medical College affiliated to a University and recognized by the Medical Council/Dental Council of India.
